ORDINANCE NO. 1022

AN ORDINANCE ADOPTING THE ATTACHED SPEED LIMITS AS THE SPEED LIMITS WITHIN THE CITY OF MOLINE ACRES FOR THE DESIGNATED STREETS.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERPERSONS OF THE CITY OF MOLINE ACRES, MISSOURI, AS FOLLOWS:

Section 1. The City of Moline Acres hereby adopts the attached speed limitations as the speed limits for the City on the designated streets therein. The attached Exhibit A is hereby adopted and incorporated into this ordinance as if fully set out herein.

Section 2. It shall be unlawful for any person to violate these speed limits.

Section 3. Any person violating this ordinance shall be subject to a fine, upon conviction, of up to One Thousand Dollars (\$1000.00) and or incarceration up to 90 days.

Section 4. This Ordinance shall be in full force and effect from and after the date of its passage.
